All graphics, all activities, all functions of the training is created by the Stakeholder and provided to the ID. The Stakeholder will be sole evaluator of courseware and have final say on layout and functionality.	The ID is to develop a course with the content provided and by direction of the Stakeholder. The ID will only build the products and materials required, and within the parameters of consistency and continuity with all other training materials for the company.	The SME will provide all necessary information and validation of the course materials as they are created. The ID will receive content provided by Stakeholder, or a designated SME, and will design courseware and materials that reflect best ID practices and learning theory. The ID will be responsible for design, layout, and graphics for all materials and products.	The SME will be responsible for all content being up to date and accurate. The SME will work with the ID to make sure that all content meets current needs and standards for training target personnel. The SME will provide resources, time with coworkers, and/or opportunities for observation and analysis to the ID as needed or requested. Create	Responsibility	The Stakeholder will be responsible for evaluating courseware and providing reasonable deadlines for deployment. The Stakeholder will also be responsible for reviewing the courseware and products for accuracy and continuity.	The ID will develop all content, courseware, materials, and products. They will be responsible to make sure that all content is up to date and accurate. The ID will be responsible for gathering all data, materials, and information from SMEs and other Stakeholders as necessary.	The SME will be responsible for providing the ID all the necessary data, content, and information that the ID will need to complete the courseware. The SME will also provide opportunity to the ID to observe and/or analyze behavior and tasks to develop additional materials for courseware development.
